Sir/Madam,

With reference to your online application dated 14.06.2009 on the subject cited above, I am directed to convey the sanction for **Composite Provisional Affiliation for Secondary and Sr. Secondary School Examination (switch over case)** of the Board for a period of **three years w.e.f. 01.04.2010 to 31.03.2013.**

The school is allowed to introduce the following subjects at Senior Secondary level during the above period:

- (a) **Languages:-**
 Hindi (Core), English (Elective), English (Core)
- (b) **Elective Subjects:-**
 Economics, Mathematics, Physics, Chemistry, Biology, Business Studies, Accountancy, Informatics Practices

The sanction is subject to the fulfillment of the following conditions:

1. "School will follow the syllabus on the basis of curriculum prescribed by NCERT for the middle classes".
2. The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Secondary School and Senior School Certificate Examinations and changes made therein from time to time.
3. The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under from Pre-Primary to Class XII depends upon campus area and facilities:-

Sub: Extension of Provisional Affiliation to the above said school beyond 31.03.2013.

Sir/Madam,

With reference to your online application dated 30/6/2012 on the subject cited above, I am directed to convey sanction of extension of provisional affiliation of the school with the Board for its Secondary School Examination and Senior School Certificate Examination for a further period of Five years w.e.f. 01.04.2013 to 31.03.2018 subject to the fulfillment of the following conditions in addition to the general conditions intimated at the time of grant of provisional affiliation for secondary and senior secondary classes :-

1. The School is required to follow syllabi and course as per scheme of studies prescribed by the Board for the respective Examination.
2. The School is required to abide itself by the Examination/ Affiliation-Bye-Laws of the Board.
3. The School is required to apply on online for further extension of affiliation alongwith the requisite fee and other documents by 30th June of the preceding year in which the Provisional Affiliation expires. Applications will be accepted after the last date along with the prescribed fee and late fee Rs. 10,000/- per month.(Amended Rule 15.11)
4. Provisional Affiliation granted to a school will remain valid on receipt of online application of a school for further extension of provisional affiliation subject to the final decision of the Board.(Amended Rule 15.11)
5. It is mandatory for every affiliated school to become a member in the local Sahodaya of CBSE schools.
6. The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under from Pre-Primary to Class XII :-
